2 Background

Pradhan Mantri Kaushal Vikas Yojana (hereafter referred as PMKVY) 2016-2020 is a flagship scheme of Ministry of Skill Development and Entrepreneurships (hereafter referred as MSDE) was launched in year 2016 with an outlay of Rs 12000 crore to train 1 crore youth of the country. PMKVY Scheme is being implemented by the state governments along with central government through two components – CSSM and CSCM. A target of 20.5 lakh is allocated to states under the CSSM component wherein the SSDMs are responsible for the formation of institutional capacities at state/ local level and working as the implementing agency in entire scheme. Under the CSCM component, the target of 79.5 lakh candidates has been assigned to NSDC with the following breakup:

Since the launch of the scheme, NSDC has been allocating targets under all three format of training component of the scheme to accredited and affiliated training centres as per the PMKVY guidelines and subsequent directions of PMKVY Executive Committee and Steering Committee. Multiple steps have been adopted for increasing the quality of the scheme including:

- One stop web-based solution for Center Accreditation, Affiliation and Continuous Monitoring (smartnsdc.org) with self-accreditation and third part inspection for centres under the scheme
- Fully online Aadhar Enabled MIS (SDMS) for candidate life cycle management with all stakeholder activity tracked online as well as online payments to all stakeholders
- Continuous monitoring and performance evaluation of the Training Centres

Annual Target Allocation for CSCM component FY18-20 is to be done through routes like RFP and performance-based re-allocation. Below is a list of categories that will be covered for allocation:

- a) Request for proposal (RFP) route
- b) Pradhan Mantri Kaushal Kendra (PMKK)
- c) Training Centres of ScPwD
- d) Special Government MoUs like Armed Forces, Railways etc.
- e) Existing PMKVY centres (Performance based re-allocation)

For the financial year 2018-2019, target allocation for around 2 lakh candidates under STT shall be undertaken under RFP. The aim of providing target via the RFP route, is to promote high quality educational institutions, government training intuitions, reputed philanthropic organizations, not for profit organizations, new training providers, who have not been associated with PMKVY 2016-18. This RFP will also consider the existing PMKVY centres which have successfully conducted trainings in particular priority districts and geographies but may not be eligible for reallocation due to lack of benchmarked performance levels. Proposals aims to bring in ITI's, NGO, startup or other agencies working in aspirational and underserved district (Annexure 19.4, 19.5) especially with marginalized community. RFP mode aims to also uniformly distribute targets across regions and geography based on aspirational district combination for wider skilling outreach.

3 Key features

The vision of the RFP implementation approach is to increase the capacity and capability of the scheme as a whole to deliver quality skill training and placement to the youth of the country and thus meet the growing demand for skilled human capital in various economic sectors.

The major steps involved in the selection of Training Providers in the project mode as per this RFP are summarized below:

1. PMKVY RFP mode focuses on the inclusiveness of Training Providers in the form of government and private institutions, small companies, start-ups, NGOs, and others.
2. Along with this, the puts emphasis on quality of Training and placement. Training organizations that wish to train candidates in aspirational districts as identified by NITI Aayog will be encouraged to apply.
3. Only organizations that have existing centers where the trainings may be conducted. NSDC does not guarantee target allocation to any organization applying through this RFP. No organization should set up any new centers for the purpose of this RFP.
4. The onboarding of centers on SMART portal is not a necessary criterion for applying in this RFP, the proposed center infrastructure should exist on ground.
5. Eligible Institutions and organizations are invited to submit proposals for allocation of targets through this RFP. The applications will be accepted only during a fixed time period.
6. Each applicant organization will have to register on an online portal.
7. Each applicant organization can submit proposal for multiple proposed centers. Each training center proposed by an applicant should contain the details of the sector for training along with job roles in which the applicant organization wishes to conduct trainings.
8. After the date of receiving applications is over, all applications will be evaluated as per the evaluation criteria
9. Training Providers, who are government owned or government institutions have been viewed as a potential Training Provider and they have been provided with special focus in scoring. Similarly, Training Providers with strong credibility, financials and skilling experience have also been encouraged through weightages on sections of scoring matrix.

10. The proposals of the TPs would be evaluated on both quantitative and qualitative parameters, which have been detailed.
11. After the evaluation, each proposed center will be ranked district wise and targets will be allocated to the applicant TP according to the target allocation methodology.
12. Due Diligence will be taken up for the shortlisted/eligible applicant organizations for the target allocation.
13. Post Approval by competent authority, the successful applicant organizations will be intimated and invited for signing of an MoU.
14. Post the allocation of targets, the applicant organizations can start training in proposed centers only after successful accreditation and affiliation of each training centre under SMART and obtaining 4/5-star rating in accordance with the centre accreditation or affiliation guidelines. In-case of Special areas as defined in common norms, valid relaxations will be applicable. Relaxations will be applicable in case of top class institutions as well.
15. The performance of the Training Providers allocated with targets would be monitored for quality aspect of Training, placement and other factors.
16. The PMKVY scheme does not allow franchising/consortium/Sub contracting.
17. The organizations applying in category 1 and 2 may request the support from NSDC for providing placements to the candidates enrolled in their centres post target allocation. The organizations who have will be given such a support will be exempted from the criteria of placement and will receive all the tranches and payments in accordance with the PMKVY guidelines except the third tranche of 20% of training cost linked to placement. The tranche 3 will be utilized by NSDC through empanelled organizations to provide placement to the candidates trained by these organizations in accordance with the PMKVY guidelines. The organizations may seek this support while applying in the RFP, approval of which will be based on organization credentials and proposal. The decision for such an exemption will be taken by the PMKVY Executive committee at the time of project approval.
18. PMKVY guidelines to be referred for more clarification in case of any ambiguity.

4 Invited Proposals

Proposals are invited to train a total of 2 lakh candidates for financial year 2018-19 across all the states and Union Territories. Applicant organization would submit proposals training center wise. Multiple training centers can be submitted by the applicant organization. Districts which are in list of aspirational districts, and underserved districts as per NITI Aayog would be given preference. Proposals shall be evaluated on a pre-defined criterion which includes but not limited to eligibility, due diligence and scoring matrix, post which would be reviewed by PMKVY executive committee.

4.1 Classification of Applicants:

Parties participating in the RFP mode will be classified in 4 categories:

- a. Category 1: Government Institutions including academic and non-academic institutions run and managed by Central/State government. Examples: Public Universities Government ITIs, CIPET, IITs, IIMs and any others
- b. Category 2: Philanthropic organizations, any registered Not-for-profit organization under Indian Societies Registration Act, Indian Trust Act, Indian Companies Act 1956/2013 (Section 25) (other than proprietorships, partnerships)
- c. Category 3: Any registered For-Profit organization under Indian Societies Registration Act, Indian Trust Act, Indian Companies Act 1956/2013, Limited Liability Partnership Act 2008 (other than proprietorships, partnerships)
- d. Category 4: Training Centres that have conducted training in PMKVY central component and have provided more than 40% placement as per the placement definition in Annexure as on 15th July 2018: Placement criteria for the Training Centers that have conducted training in PMKVY central component. Any Training center including PMKKs allocated any Target under reallocation for FY 2018-20 would not be considered for target allocation under RFP route.

Special provision for Category 1 and 2 centers only:

The organizations applying in category 1 and 2 may request the support from NSDC for providing placements to the candidates enrolled in their centers post target allocation. The organizations who have will be given such a support will be exempted from the criteria of placement and will receive all the tranches and payments in accordance with the PMKVY guidelines except the third tranche of 20% of training cost linked to placement. The organizations may seek this support while applying in the RFP, approval of which will be based on organization credentials and proposal. The decision for such an exemption will be taken by the PMKVY Executive committee at the time of project approval.

The tranche 3 of these centers will be utilized by NSDC empaneled organizations to provide placement to the candidates trained by these organizations in accordance with the PMKVY guidelines.

4.2 Eligibility conditions applicable to all categories:

2	An entity or any TC of the Entity should not be blacklisted for any project implemented by NSDC/MSDE
3	An applicant organization should not be included in the First Threshold of the PMKVY monitoring Penalty Grid
4	An applicant organization should have no statutory dues at the time of application

4.3 Submission of proposals

The proposal should be submitted online by visiting proposal management system at pmkvyofficial.org that would be accessible to training provider by 16th August 2018.

The tentative schedule for the process is highlighted in the table below:

In case the eligibility conditions of the applicant organization do not suffice the condition set by this RFP, the applicant organization will not be allowed to submit proposals.

4.4 Late Proposals

The portal accepting applications will be closed at 06:00 PM on 28th August 2018. All applicant TPs will be allowed to submit individual proposals independently during the proposal receipt window, before the deadline. Any application that has been created but not submitted by a TP on the portal will be considered null and void. No proposal will be received or considered by NSDC after the deadline for submission of proposals prescribed in this document in any form.

4.5 Proposal Preparation Cost

The Applicant shall bear all costs associated with the preparation and submission of its proposal, and NSDC shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the proposal process

4.6 Proposal Processing Fee

- a. A non-refundable one-time fee of **INR 25,000/- (Twenty-Five Thousand Rupees only)** is to be provided by all applicant TPs as a **registration fees** through any one of the multiple modes of online payment available on the project application portal.
- b. In addition to this, the TP must pay a fee of **INR 10,000/- (Ten Thousand Rupees only)** per proposal submitted for a training center.

Submission of proposal and paying of proposal processing fees under RFP mode doesn't guarantee allocation of target under PMKVY (2016-20). This RFP doesn't encourage creation of any new

training infrastructure specifically for imparting training under PMKVY. NSDC shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the proposal process.

5 Sub-Contracting/Franchise/Sub-Letting/Consortium

Sub-contracting, sub-letting, franchisee arrangement or consortium of any kind is NOT allowed for any Organization. This rule may be relaxed for category 1 institution only.

6 Evaluation Process

Evaluation of all the proposals will be done for each category only after the deadline for submission has passed. The Evaluation will be done in two stages:

- **Stage 1 - Test of Responsiveness-**

The applicant Organization will undergo a *Test of Responsiveness* under which the applicants' compliance will be checked against the eligibility criteria as per categories through the submission of the mandatory documents.

In case of any gap (in terms of compliance with submission of mandatory documents or any other document as requested by NSDC in the course of evaluation of the proposal and their completeness) in the documents submitted, the proposal will be rejected.

- **Stage 2- Desk Evaluation**

Only the proposals of the Organizations that pass stage 1 of the evaluation process will be evaluated further. NSDC or its designated evaluation agency will evaluate each Organization proposal based on their responsiveness to this RFP. This evaluation will be done in two levels.

Part A- Evaluation based on elements related to the Organization/TP (Weightage – 60%)

This will ascertain a score for each Organization with respect to Past experience in Skilling (Overall as well as performance in PMKVY scheme), Livelihood Projects, association with NSDC, Organization's credibility, affiliation with Govt. body, and Financial Strength. The weightage of this parameter is 60 points on the base of total 100 points. *This score will remain fixed for all proposals submitted by an applicant Organization.*

Part B Evaluation based on elements related to the Training Center (Weightage – 40%)

This segment will focus on the proposal of the Organization/TP which will be evaluated on the parameters proposed for a particular training center. The broad parameters are Existing Infrastructure, proposed training in aspirational districts, priority job roles and others. The weightage of this parameter is 40 points on the base of total 100 points. *This score will be variable for an Organization/TP across different training centers that the Organization/TP has applied for.*

Special focus has been given to government endorsed bodies/institutes. Each proposal for different categories shall be evaluated as per the Annexure 19.2 - Evaluation Matrix.

7 Ranking of the Proposal

The Ranking will be decided for each Organization across states based on the following scores:

- **Organization/TP related Score/Fixed Score** as per the evaluation for the applicant Organization for Part A. This score will remain constant across states and Training Center for an applicant Organization.
- **Training center related Score/Variable Score** as per evaluation for the applicant Organization for Part B – as per the Training Center proposed. An applicant Organization will score differently in each of the applied state projects for a Training Center. This will be based on the strength of the proposed project for the specified state.

Based on the total of the score (Organization/TP + Training Center/ Proposal or fixed + variable), each eligible applicant Organization will be ranked for each Training Center in each state. The ranking for same Organization may vary from one proposal to another owing to the variable score as per the part B of the evaluation matrix.

8 Allocation of project Target

Ensuring the geographical distribution leading to sector/state balance, the target allocation methodology will be based on state wise targets available. The target allocation exercise will be started only after receiving all applications subject to the last date of proposal receipt and after all the eligible applicant centers have been ranked in each district.

Rank of a proposal as per the evaluation matrix would be considered for allocation of target.

Preference will be given to the following parameters (non- exhaustive) while allocating targets:

- a) Aspirational districts (Annexure – 19.5)
- b) Underserve districts (Annexure – 19.4)
- c) Demand of proposed sector and Job Roles
- d) Total training capacity and available capacity for skill training
- e) Apprenticeship enabled training proposed (refer annexure 19.6)
- f) Government recognized award to the promoter/ director or the company
- g) Institutional rating from NAAC, UGC/AICTE etc.
- h) Geographical distribution leading to sector/state balance
- i) State wise targets available

In case all the targets are not exhausted by this exercise as per the above methodology, the decision on allocation of residual targets will be taken at a later stage based on the number of targets remaining as well as sector and geographical coverage of the scheme.

9 Evaluation by Executive Committee

All the proposals recommended for targets allocation proposed shall be presented to the PMKVY Executive Committees for the evaluation and approval. The Executive Committee shall have the final right to approve any exemption or create any special provisions on case to case basis. The executive committee will conditionally approve the training organizations and centers for target allocation subject to due diligence. Post clearance by Executive committee, the due diligence exercise will be taken up only for the selected organizations. In case there are discrepancy found in the due diligence of organizations, the proposal may be disqualified, even after recommendation by executive committee. The progress of the selected centers will be reported to committee on a six-monthly basis. In case of failure or non-compliance found during review meeting targets shall be revoked effective immediately.

10 Due-diligence

Due diligence shall form an integral part of the evaluation process. All the documentary evidences provided by the Organizations that have been shortlisted for target allocation will be taken up for the due diligence (Technical, Financial and Legal). The information and documents furnished by the applicant shall be verified by the due diligence team. The due-diligence report shall be considered for final scoring. In case of any discrepancy, the proposal will be rejected at any stage.

11 Proposal Ownership

All proposals submitted to NSDC shall become the property of NSDC, which shall not be liable to be returned to the proposer. NSDC shall, however, maintain confidentiality of the information contained within the proposals. NSDC shall be entitled to share the proposals and the information contained therein with the agencies and individuals involved in the process of evaluation and also its advisors, consultants, lawyers etc. and as may otherwise be required to be disclosed under law.

12 Right to Termination/Cancellation/Revision/Amendment

Notwithstanding anything contained in this document, NSDC, reserves the right to cancel/terminate the proposal process without assigning any reason whatsoever, at any time prior to signing of the agreement and NSDC shall have no liability for above-mentioned actions.

Further, NSDC reserves its right to revise or amend this document any time for any reason by issuance of addendum.

13 Corrupt or Fraudulent Practice

In the event of applicant engaging in any corrupt or fraudulent practices during the proposal process, as per the judgment of NSDC, the proposal shall be rejected. Any decision of NSDC in this regard shall be final and binding on the Applicant.

For the purpose of this clause:

“Corrupt Practice” means the offering, giving, receiving or soliciting of anything of value to influence the action of NSDC in the selection process. It also includes bringing undue influence through any quarter or interfering directly or indirectly in the selection process to affect its outcome.

“Fraudulent Practice” means a misrepresentation of facts in order to influence selection process to the detriment of NSDC.

14 Terms of Reference

All Organizations allocated targets shall be required to comply with the PMKVY revised guidelines as amended from time to time, for implementing the projects allocated to them. In addition, eligibility conditions mentioned in this document shall be binding on all applicants.

In case of any inconsistency, the interpretation taken by NSDC shall be final.

15 Terms & Conditions

15.1 Interpretation

In case of any ambiguity in the interpretation of any of the clauses in this document, the interpretation of the clauses by Authorized Representative/Sub-evaluation committee of NSDC shall be final and binding on all the parties.

15.2 Language

The proposal and all correspondence and documents related to the proposal exchanged by the Applicant and NSDC must be in English. Supporting documents and printed literature furnished by the Applicant may be in any language other than English provided they are accompanied by a

notary certified translation of the relevant passages in English language. Supporting material, which is not translated in English, may not be considered for evaluation. For the purpose of evaluation and interpretation of the proposal, the English language translation shall prevail.

15.3 Change in Laws and Regulations

If after the date of proposal submission, any law, regulation, ordinance, order or by-law having the force of law is enacted, promulgated, abrogated or changed which shall be deemed to include any change in interpretation or application by the competent authorities, that subsequently affects the costs and expenses of the Applicant and/or the Time for Completion, the terms and conditions shall be reasonably adjusted.

15.4 Compliance with Laws

- a) The Applicant shall undertake to observe, adhere to, comply with and notify NSDC about all laws in force or as are made applicable in future, pertaining to or applicable to the Applicant, their business, their employees or their obligations towards employees and all purposes of this document and shall indemnify, keep indemnified, hold harmless, defend and protect NSDC and its directors/employees/officers/staff/ personnel/representatives/agents from any failure or omission on its part to do so and against all claims or demands of liability and all consequences that may occur or arise for any default or failure on its part to conform or comply with the above and all other statutory obligations arising there from.
- b) The Applicant shall promptly and timely obtain all such consents, permissions, approvals, licenses, etc. as may be necessary or required for any of the purposes of this PMKVY Project or for the conduct of their own business under any applicable Law, Government Regulation/Guidelines and shall keep the same valid and in force during the term of the PMKVY Project, and in the event of any failure or omission to do so, shall indemnify, keep indemnified, hold harmless, defend, protect and fully compensate NSDC and its directors/employees/ officers/ staff/ personnel/ representatives/agents from and against all claims or demands of liability and all consequences that may occur or arise for any default or failure on its part to conform or comply with the above and all other statutory obligations arising there from and NSDC shall give notice of any such claim or demand of liability within reasonable time to the Applicant.
- c) The Applicant agrees that the Applicant shall not be entitled to assign / sub lease any or all of its rights and or obligations under this document and subsequent agreement to any entity including Applicant's affiliate without the prior written consent of NSDC.

16 Disputes and Arbitration

16.1 Arbitration

Any controversy or claim arising out of or relating to this PMKVY Project and the services to be rendered by Applicant under or pursuant to this document or agreement, the interpretation hereof, or its breach shall, if not resolved by mutual discussions between the parties, be settled by binding arbitration in accordance with the Arbitration and Conciliation Act, 1996. Arbitration shall be conducted in New Delhi in English language.

16.2 Jurisdiction

Subject to clause 16.1 above, all disputes and controversies between NSDC and Applicant shall be subject to the exclusive jurisdiction of the Courts at New Delhi. The parties agree to submit themselves to the jurisdiction of such court. This document shall be governed by the laws of India.

17 Representations and Warranties

- a) The Applicant further warrants that they are under no obligation or restriction, nor shall they assume any such obligation or restriction, that would in any way interfere or conflict with, or that would present a conflict of interest concerning, any obligations under this PMKVY Project.
- b) The Applicant represents that it is duly incorporated, validly exists under applicable Law.
- c) The Applicant represents that it has the right and authority to enter into agreement and perform its obligations there under. The execution, delivery and performance of terms and conditions under agreements by such Party and the performance of its obligations there under are duly authorized and approved by all necessary action and no other action on the part of such Party is necessary to authorize the execution, delivery and performance under agreements.
- d) The Applicant represents that the submission of responses to this document, execution, delivery and performance under an Agreement entered in case the Applicant is selected:
 - Shall not violate or contravene any provision of its documents of incorporation;
 - Shall not violate or contravene any law, statute, rule, regulation, licensing requirement, order, injunction or decree of any court, governmental instrumentality or other regulatory, governmental or public body, entity or authority by which it is bound or by which any of its properties or assets are bound;
 - To the best of its knowledge, after reasonable investigation, no representation or warranty by the Applicant, and no document furnished or to be furnished to NSDC, or in connection herewith or with the transactions contemplated hereby, contains or shall contain any untrue or misleading statement or omits or shall omit any fact necessary to make the statements contained herein or therein, in light of the circumstances under which it is made. There have been no events or transactions, or facts or information which has come to, or upon reasonable diligence, should have come to the Applicant

and which have not been disclosed, having a direct impact on the transactions contemplated hereunder.

18 Right to Change

NSDC reserves its right to change the above stated terms & conditions at any point of time without prior notice.

19 Annexures

19.1 Annexure: Placement criteria for the Training Centers that have conducted training in PMKVY central component

TC wise minimum 40% placement performance has been calculated as follows:

a. The ratio of total candidates with first reported employment since inception of PMKVY 2016-20 till 15th July 2018 as per SDMS and total candidates certified since inception of PMKVY 2016-20 till 15th April 2018 (90 days prior to cut off date i.e. 15th July 2018) will be considered.

$\% \text{ Placement} = \text{Total candidates with first reported employment till 15}^{\text{th}} \text{ July 2018} / \text{Total candidates certified till 1}^{\text{st}} \text{ April 2018}$

In addition, the training centers where the first certifications have happened between 15th April 2018 to 15th July 2018 and have given more than 40% reported placement will also be considered.

b. Only candidates whose first reported employment is present have been considered as placed. First reported employment is defined as follows:

i. Candidates whose 1st month employment record document (wage or self-employment) is uploaded on SDMS. The document uploaded must be as per the approved list of documents considered as valid proof of employment as uploaded on PMKVY website

ii. The 1st month salary slip/certificate/bank statement as applicable for the candidate as uploaded on the SDMS c. The purpose of such placement criteria for re-allocation is only to incentivize training centres to provide placement to the trained candidates. Furthermore, in due course of time all the placement records defined as per PMKVY placement guidelines for the purpose of 3rd tranche will be verified and processed.

NSDC reserves the rights to take penal action in accordance to PMKVY guidelines in case of any misrepresentation of facts/false reporting found during verification including but not limited to target revocation and financial recovery.
